### Installation:

The cross tees have connection tabs on each end, 2 cross tee sections are inserted into each slot in the main tee section but care must be taken to insert the tabs correctly so that the tees are in correct alignment. The ends of the main tee sections have offset connectors which will lock when engaged.

### Attention:

Additional measures must be followed for use in indoor swimming pools and wet rooms. Request our information sheet and contact our consulting department OWAconsult, or alternatively follow <a href="OWA-Installation Guide 9801">OWA-Installation Guide 9801</a> e.

When installing suspended ceilings in rooms according to class D, all construction interfaces must be retreated with Zincor or a commercial aluminium-zinc spray to prevent corrosion (also see section 4.3.1 of <a href="OWA-Installation Guide 9801e">OWA-Installation Guide 9801e</a>).

### **System description:**

#### Exposed grid, demountable OWAconstruct System S 3e (corrosion protection)

#### Quality requirements for mineral tiles:

OWAcoustic mineral tiles firmly bound with a primer coat on both sides. The tile is free from asbestos. No formaldehyde is added in the manufacturing process of the mineral tiles. The mineral wool used for the manufacture of the tile is bio-soluble. The criteria for non-classification as a carcinogenic substance in accordance with the Chemicals Prohibition Ordinance (Section 1 Appendix, Paragraph 23 biopersistent fibres) are met and guaranteed by the ,RAL seal of approval for mineral wool'. Verification of fitness for use according to EU CPR: CE marking and Declaration of Performance (DoP).

Mineral tiles accordance with EN 13964 and DIN 18177:

Air permeability class PM 1 Formaldehyde class FH 1 Emission of VOC TVOC 1 **Installation** should be carried out in accordance with the information contained in system leaflet S 3e and  $\underline{OWA-Installation\ Guide\ 9801\ e}$ . All components are CE labelled.
